- VA HEALTH CARE SYSTEM VISITOR POLICY

In order to protect Veterans and staff from possible exposure to COVID-19, all of our VA Health Care System facilities are continuing to limit all non-patient visitors to one individual over the age of 18 who is providing direct medical assistance to the patient. Anyone who is not a direct caregiver for the Veteran's appointment will not be permitted entry.

We also want to remind our Veterans that if you have an appointment at our main campus or one of our VA community clinics, you will be screened prior to entry and asked to answer a few simple questions by the screening staff. If you have symptoms of fever, cough, and shortness of breath, please contacts the Nurse Advice Line at 1 (877) 252-4866 before visiting us. For other healthcare concerns, you may be able to access VA care from home by phone or using VA virtual care options. Please contact your PACT Team to learn more about virtual care options.

- RESOURCES FOR VETERAN CAREGIVERS

Caregivers will now be included in Veterans' health care teams, VA Secretary Wilkie announced in the latter part of October as part of the Inclusive Care Program.

The Elizabeth Dole Foundation also offers no-cost, short-term aid from at-home care professionals to help with bathing, cooking, exercising, transportation, and companionship, among other tasks. Caregivers in every state can now apply for no-cost professional caregiver support made possible through the cooperation and donations of CareLinx, Wounded Warrior Project, AARP, and VA.

- TRICARE AND OTHER ENROLLMENTS DURING FEDERAL BENEFITS OPEN SEASON

<u>Prepare for 2021 Enrollment, TRICARE Open Season Begins</u>: Open season is almost here. Now is the time to consider whether you or your family members want to make changes to your current health, dental, and vision plan coverage.

TRICARE Select Enrollment Fees Begin Jan. 1: Starting on Jan. 1, 2021, TRICARE Select Group A retirees must pay monthly enrollment fees in order to maintain their TRICARE health coverage. You must set up an enrollment fee payment during TRICARE Open Season to start on Jan. 1, 2021.

<u>Federal Benefits Open Season Begins Nov. 9</u>: Your chance to enroll in the Federal Employees Dental and Vision Insurance Program (FEDVIP) or make changes to your existing plan is during the Federal Benefits Open Season. This year, Federal Benefits Open Season runs from Nov. 9 to Dec. 14. Your coverage will start on Jan. 1, 2021. This is a separate enrollment from TRICARE Open Season.

Your Options for Getting Health Care this Fall: Since March, military hospitals and clinics adjusted policy and procedures to keep you safe during the national health emergency due to the coronavirus pandemic. After a pause in the spring, routine appointments and elective surgeries have generally resumed but may vary depending on location. Be sure to check with your local health care provider or facility.

TRICARE Qualifying Life Events: What You Need to Know: You know you can enroll in TRICARE Prime or TRICARE Select during TRICARE Open Season. Nevertheless, did you know that certain Qualifying Life Events (QLEs) might also give you and family members the chance to enroll in a new health plan?

- DISCOVER FAMILY BENEFITS

If you're the spouse or dependent child of a Veteran or Service member, you may qualify for certain benefits like health care, life insurance, and money to help pay for school or training. - SWITCH TO DIRECT DEPOSIT WITH VBBP

As we celebrate Veterans this November, the Veterans Benefits Administration (VBA) strives to provide benefits faster and better than ever before! If you're a Veteran, you can receive your VA benefit payments in a more secure, reliable, and inexpensive way by signing up for the Veterans Benefits Banking Program (VBBP). With VBBP, you can have your VA benefits deposited directly into your bank account instead of receiving a pre-paid debit card or paper check!

- NEW ID CARDS FOR RETIREES, FAMILY MEMBERS ARE HERE

Defense Department began issuing Next Generation Uniformed Services Identification Cards, the first time since 1993 that changes to the card have been made. The complete transition to the new ID card is targeted for January 2026, said Michael Sorrento, director of the Defense Manpower Data Center. In the meantime, the current cards will continue to work. In an effort to conserve resources and limit the impact on ID card issuance

facilities, cards will not be reissued solely for the purpose of obtaining the Next Gen USID card. Sorrento discussed the new ID cards that are for military family members, retirees and other eligible card holders. The new ID card uses a much more durable plastic material, similar to that used for the common access cards used by military members and DOD civilians, he said. Also, the new ID cards feature enhanced security measures that will reduce the likelihood of them being compromised, Sorrento said. Although the new ID cards are available now, Sorrento said, only about 20 Real-Time Automated Personnel Identification Card System sites currently offer the card.

All RAPIDS sites worldwide likely will have the new equipment by the end of the year, he said. To reduce foot traffic -- particularly in light of the COVID-19 pandemic -- Sorrento said that unless a card is about to expire, it would be better to wait until next summer to get a new one. Even then, he added, it would be good to call ahead first to schedule an appointment.

- VA HONORS CAREGIVERS OF VETERANS THROUGHOUT NOVEMBER

During National Family Caregivers Month this November, the U.S. Department of Veterans Affairs (VA) will honor the caregivers of Veterans for their invaluable health care, acknowledging the critical role they play in caring for Veterans every day — and even more so during the COVID-19 pandemic.

VA medical centers nationwide will host virtual events to raise awareness of the Caregiver Support Program's recent expansion and to highlight the contributions of Veterans' caregivers. "Caregivers are important members of a Veteran's health care team and the pandemic has amplified their significance," said VA Secretary Robert Wilkie. "We recognize their ongoing commitment to the well-being of Veterans and the roles they play in Veterans' lives daily. Providing a wide range of resources to help them care for Veterans and themselves is paramount."

As part of VA's historic change to the Caregiver Support Program, the department began the first phase of expanding its Program of Comprehensive Assistance for Family Caregivers (PCAFC), Oct. 1, which extended the program to eligible Veterans who incurred or aggravated a serious injury in the line of duty on or before May 7, 1975. The second phase, effective Oct. 1, 2022, will expand the program to eligible Veterans who incurred or aggravated a serious injury in the line of duty between May 7, 1975 and Sept. 11, 2001. PCAFC offers assistance to Family Caregivers of eligible Veterans, including education and training, respite care, a monthly stipend and more.

VA also offers caregivers of Veterans services under the Program of General Caregiver Support Services (PGCSS). PGCSS is available to all caregivers who provide personal care services to covered Veterans enrolled in VA health care. PGCSS participants have access to education and training, respite care, and additional services such as VA's Peer Support Mentoring.
